AGREEMENT:

This agreement constitutes your agreement with the Arabian Horse Association of New York (AHANY) and the Eastern Classic Horse Show (The Show) to vendor during the Eastern Classic Horse Show June 7th to June 9th 2019. The concessionaire/vendor agrees to hold harmless the Arabian Horse Association of New York (AHANY) and the Eastern Classic Horse Show (The Show) and their officials, directors, employees, agents or volunteers for any injury or loss suffered during or in conjunction with the competition, whether or not such injury or loss resulted directly or indirectly from the negligent acts or omissions of said officials, directors, employees, agents or volunteers of the Arabian Horse Association of New York and the Eastern Classic Horse Show.

License(s) and permits are the responsibility of the vendor. Sales Tax authorizations must be displayed, and sales tax collection/payment is the responsibility of the vendor.

EXHIBIT RULES AND REGULATIONS

2019 Eastern Classic Arabian Horse Show

Friday, June 7 to Sunday, June 9, 2019, - Erie County Fair Grounds, 5600 McKinley Parkway, Hamburg, NY

EXHIBITOR RESPONSIBILITY:

Each exhibitor must name at least one person as a representative in connection with installation, operation and removal of exhibit. Such representative(s) shall be authorized to enter into such service contracts as may be necessary and for which the exhibitor shall be responsible. These Exhibitor Rules and Regulations shall become binding upon execution of an Exhibitor Registration Form for a specific conference or meeting.

SPACE ASSIGNMENT:

Assignment of space will be made on a first-come, first-serve basis. Arabian Horse Association of New York reserves the right of final decision and the right to amend floor plans to relocate exhibits as necessary. Arabian Horse Show Association of New York reserves the right to refuse to rent space to any company whose display is not compatible, in the opinion of Arabian Horse Show Association of New York, with the objectives of the exhibition, with or without giving cause. If cause is not given, liability shall not exceed the return to the exhibitor's registration and booth fees. If an exhibit or exhibitor is ejected for violation of these rules or for any other stated reason, no return of payment shall be made.

BOOTH AND SIGN:

Single booths are generally 10 feet by 10 feet in size, unless otherwise noted on the specific exhibit floor plan. In addition to the space itself, the rental fee includes one 8 ft. table, two chairs and a company identification sign. Maximum exhibit height is 8 feet. Exhibits may be prohibited which do not conform to the specifications, or which in design, operation or otherwise are objectionable or a safety concern in the opinion of Arabian Horse Association of New York and Show Committee.

SET UP TIME, INSPECTION AND TEAR DOWN:

Set Up Time: Thursday, June 6 from 9:00 am to 5:00 pm

Tear Down: After Show Closes on Sunday, June 9th to 8:00 pm

SECURITY:

Reasonable care and security during the open hours of the horse show from the beginning of set-up through dismantling is our policy. Arabian Horse Association of New York, the Exhibit Hall facility, and the Erie County Fair Grounds, however, are not responsible for any loss, theft, or damage of property belonging to the exhibitor, exhibitor's employees, or exhibitor's representatives.

FIRE & SAFETY LAWS:

Federal, State and City Laws must be strictly observed. Cloth decorations must be flameproof. Wiring must comply with fire department and underwriters' rules. Smoking in exhibits and barns is strictly prohibited. Crowding will be restricted. Aisles and fire exits cannot be blocked by exhibits. No decorations of pine boughs, leafy decorations or tree branches are allowed. Exhibitor will not do anything in the exposition facility that will increase insurance rates.

DEFACING OF BUILDING:

Exhibitors are liable for any damage caused by fastening displays or fixtures to the building floors, walls, or to the standard booth equipment, or for damage caused in any manner. Exhibitors may not apply paint, lacquer, adhesive or any other coating to building walls and floors or to standard booth equipment.

LIABILITY:

This agreement shall not constitute or be considered a partnership, employer-employee relations, joint venture or agency between Arabian Horse Association of New York, Erie County Fair Grounds and the exhibitor. Exhibitor hereby agrees to and does indemnify, hold harmless and defend Arabian Horse Association of New York and Erie County Fair Grounds from and against any and all liability, responsibility, loss, damage, cost, or expense of any kind whatsoever (including, but not limited to cost, interest and attorney's fees) which Arabian Horse Association of New York and Erie County Fair Grounds may incur, suffer, be put to, pay or be required to pay incident to or arising directly or indirectly from any intentional or negligent act or omission by exhibitor or any of its employees, servants, or agents, subject to the provisions herein.

Exhibitor further agrees that Arabian Horse Association of New York, Erie County Fair Grounds and their respective agents and employees shall not be responsible in any way for (a) damage, loss or destruction of any property of exhibitors or (b) injury to exhibitor or its representative, agents, employees, licensees, or invitees; and agrees to and does indemnify, hold harmless and defend Arabian Horse Association of New York and Erie County Fair Grounds from any claims arising out of damage, loss or destruction under (a) or (b) herein.

HOLD HARMLESS CLAUSE:

The exhibitor assumes the entire responsibility and liability for losses, damages and claims arising out of injury or damage to exhibitor's displays, equipment, and other property brought upon the exposition premises and shall indemnify and hold harmless the exposition side, Arabian Horse Association of New York and Erie County Fair Grounds, their agents, servants and employees from any and all such losses, damages and claims.

INABILITY TO HOLD SHOW:

If because of war, fire, strike, exhibit facility construction or renovation project, government regulations, public catastrophe, act of GOD or the public enemy, or other cause beyond the control of Arabian Horse Association of New York, or any part thereof, is prevented from being held or is canceled, or the Exhibit space becomes unavailable, Arabian Horse Association of New York, in its sole discretion shall determine and refund to the exhibitor its' registration and booth fees after deducting expenses incurred by this meeting and reasonable compensation to Arabian Horse Association of New York, but in no case shall the amount of the refund to the exhibitor exceed the amount of exhibitor fee paid. Arabian Horse Association of New York shall have no other further liability to the exhibitor. The exhibitor may consider obtaining appropriate insurance coverage at its cost and expense for this contingency.

CHARACTER OF DISPLAYS:

The lessor, in its sole discretion, reserves the right to restrict exhibits which, because of noise, size, methods of operation or for any other reasons, become objectionable, safety concerns and also to prohibit and evict any exhibit which, in the opinion of the lessor, may detract from the general character of the display. This reservation includes persons, things, conduct, printed matter or anything of the character which may be objectionable to the exhibit as a whole. In the event of such restriction or eviction, the lessor is not liable for any refunds or rentals or other exhibition expense. No exhibit shall violate any municipal, state, or federal law, rules or regulations, including safety codes. All display materials must be flame retardant. All aisle space belongs to the show; no exhibits or advertising matter shall be allowed to extend beyond the booth space.

SUB-LEASING:

Exhibitors may not sub-let, share, or assign their space, nor any part thereof, to another company without permission from Arabian Horse Association of New York.

AMENDMENT TO & COMPLIANCE WITH RULES:

Any and all matters or questions not specifically covered by the preceding rules and regulations shall be subject solely to the decision of Arabian Horse Association of New York. These rules and regulations may be amended at any time by Arabian Horse Association of New York and all amendments so made shall be binding on exhibitors equally with the foregoing rules and regulations. AHANY, The Show and venue reserve the right to impose reasonable rules and regulations.

ADVERTISING MATERIAL:

Circulars or advertising matter may be distributed from the exhibit booth only. Advertising material may not be placed on the meeting or seminar room seats, or tables or on tables outside the exhibit booth.

RIGHT TO REFUSE APPLICATION TO EXHIBIT AND/OR MOVE EXHIBIT

The Arabian Horse Association of New York Eastern Classic Arabian Horse Show Committee shall review all applications from proposed exhibitors. The Committee shall have the authority and the duty to reject any and all applications.

Arabian Horse Association of New York, AHANY and/or the Erie County Fair Grounds has the right to move exhibitor booth or request activity to cease within booth if safety concerns are raised.

CANCELLATION POLICY

Booth Cancellations received on or before June 1st will receive a refund of the amount paid minus a 10% fee. After June 1st no refunds will be made.
