# EASTERN CLASSIC SHOW ENTRY RULES

## **PRE ENTRIES CLOSE May 16th.**

No entries accepted by phone. Check or Credit Card for FULL payment must accompany entries. Entries made at the Show will be charged a late fee of \$30.00 per horse. Class fees will be at the regular fees, no additional post entry fees will be charged.

Canadian Exhibitors must pay in US funds either by money order or check, drawn on a US Bank. Credit Cards can be accepted.

**RETURNED CHECKS** Checks returned by the bank will be charged 10% of the face value of the check or \$50.00, whichever is the greater amount. No post dated checks will be accepted without prior approval of the show manager.

**SHOW ACCOUNTS** An open account is highly recommended for post entries etc. A signed, blank check payable to AHANY must be left on file in the show office. If a posted class is charged to the exhibitor's account, and is later scratched, the exhibitor is still responsible for payment of that class. Even exchanges for post entries and scratches will be allowed (with the exception of the sport horse in hand and dressage rides), provided they are done at the same time and are the same owner or payee. No prize money checks will be issued until the exhibitor has settled his show account. Prize money vouchers may be used as a credit against the exhibitors show account.

## **TO BE ANNOUNCED (TBA) CLASSES:**

**TBA CLASSES** must be purchased prior to the start of the show. Purchase includes class entry.

TBA Classes may be any class on the AHA List or recognized by AHA with the exception of any class requiring cows, or any class requiring fences/obstacles.

Selected TBA classes will be posted in the show office prior to the start of the show.

**PRIZE MONEY/AWARDS** Prize money vouchers or awards will be given out with the ribbons. Vouchers may be turned in at the end of the show for a check/cash or to use against your bill. No prize money checks will be issued until after the exhibitor's last class. Prize money or awards not claimed will not be mailed and are forfeit.

Championship classes with prize money need 4 or more entries for payout.

**REFUNDS - VET OUTS - DR'S NOTES** A full refund, less the office fee if vet out/Dr's note is received before the show closing date. After the closing date Vet/Doctors certificate must be in the Show Secretary's hands before the end of the show. Stalls fees, Office fees and all mandatory fees are NOT refundable. NO REFUNDS ONCE ON THE SHOW GROUNDS..

**SCRATCHES** The office must be notified if a horse does not intend to show in a class that it is entered in. A \$20.00 no show fee will be charged to the exhibitor for not notifying the office. In the case where a horse has been entered and not shown, class fees are forfeited.

**HIGH POINT AWARD RULES:** Selection of classes is decided by Show Management Sign up is NOT required to participate. Points will be tabulated on the rider regardless of how many horses the exhibitor rides.

Points tabulated as follows:

1st - 6pts	2nd - 5pts	3rd - 4pts
4th - 3pts	5th - 2pts	6th - 1pt

TBA Classes, Trail, Dressage and Championship classes will NOT count.

Walk/Trot/Jog High Point will be all W/T/J classes 10 & under.

Junior Exhibitor High Point will include: ATH, JTH, ATD, ATR, JTR, JOTR, & AOTR

Adult Amateur High Point will include: ATH, AATH, AAOTH, ATD, ATR, AATR, AAOTR, & AOTR

The highest scoring rider receives a Champion ribbon and an award. The second highest scoring rider receives a Reserve Champion ribbon.

## **FACILITY INFORMATION**

**PARKING** All horse trailers must park outside the gate up on the hill past the outdoor show ring. No trailers are allowed to park in the parking lot within the gated area.

**CAMPER HOOKUP** There are plenty of spaces available for campers that require electrical & water hookup. Spots will be on a first come first serve basis. No camper spots will be reserved over the phone. You must register at the show office, pay your camper fee, and give your license plate number to the Show Office before receiving a camper permit. You will not be able to pick up your entries without following the above mentioned procedure. This will be strictly enforced. Permits must be displayed in your camper door or window. Management will be verifying the display of these permits.

## **SHOW RING INFORMATION**

Showplex ring: 228 ft x 118 ft - sandy loam mix.

Warm-up ring: 62 ft x 228 ft - sandy loam mix.

Outside Dressage Warm-up Ring: Standard size with a limestone & sand mix.

**LUNGING** There is to be no lunging or long lining in the holding area or warm up ring when classes are in session. The ring will have lights on until 11pm Wednesday, Thursday, Friday and Saturday nights. For safety purposes during down time no lunge whips are allowed in the Showplex ring when horses are being ridden.

**NO SMOKING IS PERMITTED IN OR NEAR THE BARN**

**NO ALCOHOLIC BEVERAGES ALLOWED IN THE SHOWPLEX ARENA AREA**

**ALL DOGS MUST BE ON A LEASH**

**LIABILITY RELEASE** The Show Committee, sponsoring associations, their agents, and employees will not be held responsible for any accidents which may occur to or by any rider, driver, groom attendant, spectator, animal or equipment while on the show grounds.

## **STABLING & ARRIVAL INFORMATION**

**STALLS** are standard portable stalls with full doors located inside permanent buildings with concrete floors.

Stall reservations forms must be filled out & returned with full payment. Stalls will be assigned using the reservation form. Only one form required per group wishing to be stalled together.

**STABLE LIGHTING WILL BE REDUCED FROM 11PM - 5AM**

PER GR1215.4: For 6 consecutive hours overnight, stabling must have minimal lighting and noise to allow stabled horses adequate rest.

**Stalls will be available starting Wednesday @ Noon** for the weekend. Anyone arriving earlier, please call show management.

ASSIGNMENT OF STALLS IS ENTIRELY AT DISCRETION OF SHOW MANAGEMENT - Please contact the Barn Manager for specific requests.

PLEASE NOTE: TACK STALLS MAY BE LIMITED to accommodate horses first.

**SHAVINGS** may be ordered on the stall reservation form or by calling Vendor. Vendor pricing coming soon. NO Initial bedding will be furnished.

Please pre-order shavings BY June 1st

**SHOWING OUT OF TRAILER** Showing horses from the trailer not permitted. Please contact the barn manager for day stalls.

## **HORSE HEALTH DOCUMENTATION NY HORSES**

Negative Coggins Test (taken within last 2 years prior to show date)

Current Rabies Vaccine within 1 yr

EIV/EHV-1&4 Vaccine Cert within 6 months

Horses not in compliance with this rule may be required to leave the competition grounds upon request of Show Management

OUT OF STATE HORSES includes the above listed documentation and additionally a Health Certificate (dated within 30 days)

## **MOTORIZED VEHICLE STATEMENT**

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions.

Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense.

Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hoverboards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. .

**SHOW MANAGEMENT** Show Management will be charged with the responsibility of enforcing all USEF and AHA rules. Special emphasis will be placed on the rules pertaining to the retention of natural action; expressly hoof length, weighted shoes, pads, or action brought about by these or similar artificial appliances. Leg chains, rattlers, or other artificial appliances on a horse's legs while on the show grounds will be an immediate cause for removal from the Show, and all monies, ribbons, and trophies shall be forfeited.

Show Management reserves the right to change judging assignments if necessary. Show Management also bears the responsibility to aid the judges in avoiding contact with exhibitors or their agents before and during the show. If any exhibitor has made false statements regarding an animal or article exhibited, or if any exhibitor shall attempt to interfere with the judges in the performance of their duties, he or she

shall be excluded from exhibiting.

Any act of discourtesy or disobedience to the officials on the part of the owner, rider, groom, exhibitor, or driver shall disqualify the horse from being judged. Show Management reserves the right to remove from the grounds any of the aforementioned without being liable for compensation or damages. The Show Management reserves the right to decline to receive any entry, and to return any entry fee(s) and/or stabling charges before or during the show without being liable for any compensation.

No person will be allowed in the ring except participants in the class, judge, assistants, and show photographer. Attendants will be allowed only being called by the judge or ringmaster. No exhibitor shall approach a Judge with regards to a decision unless they FIRST obtain permission from the Steward who shall arrange an appointment with the Judge.

## **AHA MEMBERSHIP STATEMENT**

EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR. WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP. SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS. EXHIBITORS IN WALK-TROT CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS. EXHIBITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS. (BOD 5/12)

**USEF MEMBERSHIP STATEMENT:** Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule:

1. leadline;
2. exhibitions;
3. games and races;
4. classes for 4-H members;
5. walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program);
6. USDF introductory level tests, pas de deux and quadrille classes;
7. assistant handlers in Dressage Sport Horse Breeding classes

**SAFE SPORT REMINDER:**

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes are required to comply with the U.S. Center for SafeSport training requirements to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. 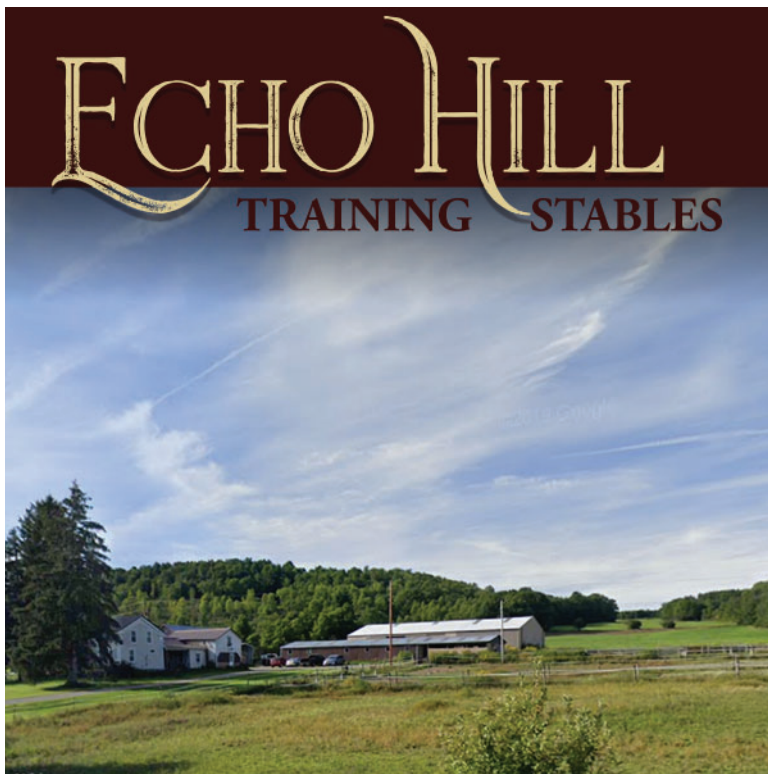



### AHA ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION **This document waives very important legal rights. Read it carefully before signing.**

In consideration for AHA permitting me to participate in this Competition, and by signing the entry blank, I agree as follows:

**I AGREE** that I choose to participate voluntarily in this Competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. **I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.**

**I AGREE** as a Horse Show Participant (or Parent/Guardian of Participant if a minor) to waive all claims which may otherwise arise from, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Horse Show (and most other outdoor locations) and can cause infection in humans, as well as in animals.

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

**Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

**Memberships Defined**

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

**How to Join USDF**

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.
